TO THE MEMBER STATES AND ASSOCIATED MEMBERS OF OTIF AND TO REGIONAL ORGANISATIONS THAT HAVE ACCEDED TO COTIF

16th Session of the RID Committee of Experts' standing working group (London, 20 to 23 November 2023)

- 1. At its 15th session (Berne/hybrid, 23 and 24 November 2022), the RID Committee of Experts' standing working group agreed to hold its 16th session from 20 to 24 November 2023 (see report <u>OTIF/RID/CE/GTP/2022-B</u>, paragraph 39).
- 2. On the basis of the documents available so far, the Secretariat and the Chair decided to shorten the meeting by one day.
- 3. Following the global recovery from the effects of the COVID 19 pandemic, it was decided to return to normal business and organise the meetings of the RID Committee of Experts' standing working group as in-person meetings only.

4. The 16th session of the RID Committee of Experts' standing working group will be held from 20 to 23 November 2023. **The meeting will start at 14.00 GMT on 20 November 2023 and will end at 17.30 GMT on 23 November 2023.**
