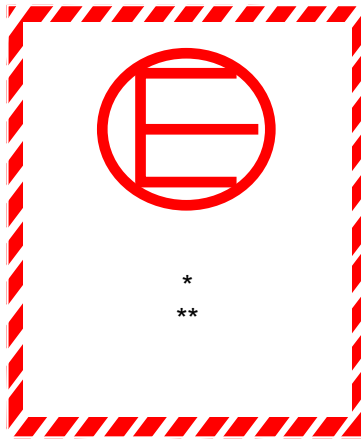
In the Table under transport category 1 in column (2) under "Class 2" after "TOC", add a reference to footnote a).*
